II.2.1 BENCH RULES POLICY STATEMENT - TO KEEP COSTS DOWN, WE ASK TEAMS TO PROVIDE A VOLUNTEER SCORER. ONE SCORER FROM EACH TEAM HELP INPUT SCORES AND FOULS INTO IPAD AND SCOREPAD. PLEASE ASK UMPIRES OR SUPERVISORS FOR ASSISTANCE.

II.2.2 BENCH RULES PENALTY STATEMENT - WITHOUT A SCORER, THE NON-COMPLIANT TEAM WILL GIVE 5 POINTS TO THE OPPOSITION FOR THE FIRST INSTANCE. ON THE SECOND INSTANCE, 10 POINTS WILL BE GIVEN TO THE OPPOSITION. ON AND AFTER THE THIRD INSTANCE, THE NON-COMPLIANT TEAM MAY BE REQUIRED TO FORFEIT THE GAME, WITHOUT REFUND TO THE NON-COMPLIANT TEAM.

U25 = BORN YEARS 2000 TO 2006

II.4 UNIFORM POLICY

IT IS A REQUIREMENT THAT ALL PLAYERS ARE IN MATCHING UNIFORMS PRIOR TO THE START OF THE GAME. IN ORDER TO PROVIDE THE HIGHEST POSSIBLE SERVICE, COMPLIANCE TO THIS POLICY WILL BE A PRIORITY.

i) All players on a team shall wear the same colour top with a unique number
ii) Matching bottoms shall also be worn on each player.
iii) Nose studs and ear studs can be covered.
iiv) Any size metal ring or loop on the exposed surface of the skin is prohibited.
v) Bibs may not be available to hire at all times - may incur a cleaning & handling fee

II.4.1 UNIFORM POLICY STATEMENT - THE OPEN DISTRICTS BASKETBALL LEAGUE WILL NOT ACCEPT PLAYERS WITHOUT A PROPER UNIFORM. IT IS THE RESPONSIBILITY OF THE PLAYER/GUARDIAN TO PROVIDE PLAYERS WITH APPROPRIATE UNIFORMS. UNIFORMS MAY BE BORROWED FROM EACH OTHER AND NUMBERS MAY BE CHANGED, BUT A MATCHING **COLOUR** UNIFORM IS REQUIRED TO PARTICIPATE.

II.4.2 UNIFORM PENALTY STATEMENT - WE DO NOT DESIRE TO ENACT POINT PENALTIES - WE PREFER COMPLIANCE. IN THE EVENT OF NON-COMPLIANCE, THE **PLAYER** WILL **RECEIVE** A **FOUL** AND THE **TEAM** WILL **GIVE 2 POINTS** TO THE OPPONENT PER INFRACTION, UP TO 4 POINTS. IF MORE THAN 2 PLAYERS ARE NON-COMPLIANT, GAME WILL BE FORFEITED. IN THE EVENT OF A FORFEIT, THE COMPLIANT TEAM WILL RECEIVE A REFUND AND THE FORFEITING TEAM WILL NOT.

II.5 PAYMENT POLICY

II.5.1 PAYMENT POLICY STATEMENT - TEAMS ARE REQUIRED TO PAY FOR GAMES PRIOR TO TAKING THE COURT. PAYMENTS ARE MADE VIA STARPLEX RECEPTION. A RECEIPT WILL BE PRINTED OUT. THIS RECEIPT SHALL BE PRESENTED TO THE GAME'S UMPIRE OR COURT SUPERVISOR PRIOR TO THE START OF THE GAME. NO PAYMENT, NO PLAY.

II.5.2 PAYMENT PENALTY STATEMENT - AUDITS ARE REGULARLY UNDERTAKEN TO ENSURE EACH TEAM IS COMPLIANT WITH PAYMENTS ON GAME NIGHT. REPEAT OFFENDERS RUN THE RISK OF BEING WITHDRAWN FROM THE COMPETITION UNTIL ALL DEBTS ARE PAID. FORFEITS CARRY AN ADDITIONAL FEE IF LESS THAN 24 HOURS.
